第10届中国—东盟商务与投资峰会主要成果

1. 中国国务院总理李克强在开幕大会上发表题为“推动中国—东盟长期友好互利合作战略伙伴关系迈上新台阶”的主旨演讲，提出5点倡议：一是打造中国—东盟自贸区升级版，二是加快推进公路、铁路、水运、航空、电信、能源等领域互联互通合作，三是加强金融合作，四是开展海上合作，建立“中国—东盟海洋伙伴关系”，五是增进人文交流，把2014年确定为“中国—东盟友好交流年”。

2. 缅甸总统吴登盛、柬埔寨首相洪森、老挝总理通邢、泰国总理英拉、越南总理阮晋勇、新加坡副总理张志贤，东盟秘书处秘书长黎良明，中国商务部国际贸易谈判代表兼副部长钟山，中国广西壮族自治区党委书记、人大常委会主任彭清华在开幕大会上分别发表讲话。中国国际贸易促进委员会会长万季飞代表中国—东盟商务与投资峰会致辞。中国广西壮族自治区人民政府主席陈武主持开幕大会。

Achievements of the 10th CABIS

1. H. E. Li Keqiang, Premier of China delivers a keynote speech at the opening ceremony on “Bring the China-ASEAN Strategic Partnership of Long-term Friendship and Mutually Beneficial Cooperation to a New High” and puts forward 5 proposals: (1) to build an upgraded version of the CAFTA, (2) to promote connectivity cooperation in road, rail, waterway, aviation, telecommunication and energy, (3) to enhance financial cooperation, (4) to carry out maritime cooperation and call for establishing China-ASEAN maritime partnership, (5) to increase people-to-people exchanges and propose that the year 2014 be designated as the China-ASEAN Friendship and Exchange Year.

2. H. E. U Thein Sein, President of Myanmar, H. E. Samdech Hun Sen, Prime Minister of Cambodia, H. E. Thongsing Thammavong, Prime Minister of Laos, H. E. Yingluck Shinawatra, Prime Minister of Thailand, H. E. Nguyen Tan Dung, Prime Minister of Vietnam, H. E. TEO Chee Hean, Deputy Prime Minister of Singapore and H. E. Le Luong Minh, Secretary-General of the ASEAN, H. E. Zhong Shan, International Trade Representative and Vice Minister of Commerce of China and H. E. Peng Qinghua, Secretary of the CPC Guangxi Committee and Chairman of Guangxi People’s Congress, China, deliver speeches at the opening ceremony. H. E. Wan Jifei, Chairman of CCPIT gives remarks on behalf of CABIS. The opening ceremony is chaired by H. E. Chen Wu, Governor of Guangxi Zhuang Autonomous Region, China.

3. China-ASEAN Business Leaders Forum is successfully held.

H. E. U Thein Sein, President of Myanmar sends a congratulatory message to celebrate the 10th anniversary of CABIS. H.E. U Tin Oo, Ambassador of Myanmar to China announces the message at the forum.

The Honorable Dato’ Sri Mohd Najib bin Tun Haji Abdul Razak, Prime Minister of Malaysia sends a congratulatory message to celebrate the 10th anniversary of CABIS. Mr. Mohd Ridzal Sheriff, Deputy Secretary General of Ministry of International Trade and Industry of Malaysia announces the message at the forum.

H. E. Dr. Boediono, Vice President of Indonesia sends a congratulatory message to celebrate the 10th anniversary of CABIS. H. E. Imron Cotan, Indonesian Ambassador to China announces the message at the forum.

Dialogue on Economic and Trade Cooperation in Commemoration of the 10th Anniversary of China-ASEAN Strategic Partnership is held in cooperation with CCTV and chaired by Mr. Chen Weihong, anchor of CCTV's program "Dialogue". Theme: China-ASEAN: Cooperate for Win-win Outcome. Guest speakers H. E. Dato' Sri Mustapa bin Mohamed, Minister of International Trade and Industry of Malaysia, H. E. Zhong Shan, International Trade Representative and Vice Minister of Commerce of China and H. E. Huang Daowei, Executive Vice Governor of Guangxi Zhuang Autonomous Region, China, express and exchange their views. As interactive speakers, Mr. Thanakorn Seriburi, Vice Chairman of Chia Tai Group and Chairman of Thailand-China Business Council, Mr. Luo Tao, General Manager of China Nonferrous Metal Mining(Group) Co., Ltd, Mr. Mohd Haris bin ab Aziz, President of Sanbao Resources (ASIA) Inc., and Mr. Tan Khee Giap, Associate Professor & Co-Director of Asia Competitiveness Institute and Chair of Singapore National Committee for Pacific Economic participate in the dialogue.

5. The Round-Table Dialogue between Senior Leader of the Republic of the Philippines and CEOs from China is successfully held. Topic: deepening China-Philippines economic and trade cooperation for mutual development. H. E. Gregory L. Domingo, Secretary of Department of Trade and Industry of the Philippines has a dialogue with 5 CEOs from China: Mr. Liang Huijiang, Director General of International Finance Department of China Development Bank, Mr. Tang Yi, President of China National Technical Imp. & Exp. Corp., Mr. Wang Xusheng, President of China National Machinery Import & Export Corporation, Mr. Wang Yu, President of China International Water & Electric Corporation and Mr. Dai Zhihua, CEO of Huawei Technologies Philippines, Inc. who have played an important role in promoting the bilateral economic and trade cooperation between China and the Philippines. Projects totaling USD 1.42 billion cooperated by Chinese and Philippine enterprises in tourism, clean energy, infrastructure and financial service sectors are promoted. The dialogue is chaired by H. E. Ponciano C. Manalo Jr., Undersecretary of Department of Trade and Industry of the Philippines and co-chaired by Mr. Atty. Miguel B. Varela, President of PCCI. Mr. Dong Songgen, Vice Chairman of the Organizing Committee of CABIS and CCPIT gives opening remarks and Mr. Huang Ribo, Vice Governor of Guangxi Zhuang Autonomous Region, China, gives welcome remarks.

6. The 2013(the 4th) China-ASEAN Mining Cooperation Forum and Exhibition witnesses the signing of contracts totaling RMB 5.19 billion and the inauguration of China-ASEAN Mining Personnel Exchange and Training Center.
