来由

2003年10月，中国国务院总理温家宝在印度尼西亚巴厘岛举行的第七次中国—东盟（10+1）领导人会议上提出，每年在中国举办中国—东盟商务与投资峰会，作为推动中国—东盟自由贸易区建设的一项实际行动。这一建议得到东盟各国领导人的积极响应，并写入会议的主席声明。

2004年11月，第一届中国—东盟商务与投资峰会在南宁成功举行。

Initiation

In October, 2003, at the 7th China-ASEAN (10+1) Summit held in Bali, Indonesia, ASEAN leaders responded positively to the proposal made by H.E. Wen Jiabao, Premier of China, which called for the annual convening of China-ASEAN Business and Investment Summit in China, as part of the actual efforts working towards the realization of the China-ASEAN Free Trade Area (CAFTA). This consensus was then voiced in the Chairman's Statement of the summit.

In November, 2004, the 1st CABIS was duly held in Nanning with full success.







第18届中国—东盟商务与投资峰会主要成果

1. 中国国家主席习近平向第18届中国—东盟博览会和中国—东盟商务与投资峰会致贺信，表示面向未来，中方愿同东盟增强战略互信，深化抗疫、经贸等各领域合作，推动区域全面经济伙伴关系协定早日生效实施，高质量共建“一带一路”，打造更高水平的战略伙伴关系，共同维护好本地区繁荣发展良好势头。中国国家副主席王岐山在开幕大会上发表主旨演讲，提出5点倡议：一是对接发展战略，提升伙伴关系；二是拓展经贸合作，增进人民福祉；三是深化抗疫合作，加强公共卫生能力建设；四是培育发展新动能，促进地区经济加快复苏；五是扩大社会人文交流，促进民心相通。
2. 老挝总理潘坎、文莱苏丹哈桑纳尔·博尔基亚陛下、柬埔寨首相洪森、马来西亚总理伊斯迈尔、泰国总理巴育、巴基斯坦总统阿里夫·阿尔维、新加坡副总理兼经济政策统筹部长王瑞杰、越南副总理黎文成、缅甸商务部部长本山、东盟秘书长林玉辉在开幕大会上分别视频致辞。中国广西壮族自治区党委书记、人大常委会主任鹿心社，中国商务部副部长、国际贸易谈判副代表俞建华，中国—东盟商务与投资峰会组委会主任、中国国际贸易促进委员会会长高燕在开幕大会上分别发言。中国广西壮族自治区主席主持开幕大会。
3. 成功举办老挝副总理兼计划投资部部长宋赛·西潘敦与中国企业CEO圆桌对话会。主题：共享发展新机遇，共谋合作新成果。老挝副总理兼计划投资部部长宋赛·西潘敦与在中老经贸合作中发挥重要作用的5位中国企业CEO：中国南方电网有限责任公司董事长孟振平、中国大唐集团有限公司党组副书记、董事时家林、中国建筑集团有限公司副总经理、党组成员马泽平、中国铁路国际有限公司总经理、党委副书记高峰分别开展对话。双方在基础设施建设、电力、数字经济等领域达成共识，推进92.95亿美元项目的合作。老挝驻华大使坎葆·恩塔万主持对话会。中国—东盟商务与投资峰会组委会主任、中国国际贸易促进委员会会长高燕，中国广西壮族自治区主席致辞。中国广西壮族自治区副主席邹展业，中国国际贸易促进委员会副会长张少刚于南宁出席对话会。老挝公共工程与运输部部长翁萨瓦·西潘敦、老挝能源与矿产部部长道旺·冯奇欧、老挝计划投资部副部长康占·冯森本、老挝技术与通信部副部长布萨赛·坎翁、老挝中央银行副行长瓦塔纳·达洛伊、老挝工贸部副部长宋吉·英塔米于万象出席对话会。

4. 成功举办中国—东盟商界领袖论坛暨中国—东盟建立对话关系30周年特别会议。主题：携手三十载 共绘新时代。中国国际贸易促进委员会会长、中国—东盟商务与投资峰会组委会主任高燕，中国广西壮族自治区政协主席孙大伟出席论坛并致辞，泰国副总理兼商业部部长朱林·拉萨纳维席，以及文莱国家工商会主席哈纳夫、柬埔寨总商会主席陈丰明、印度尼西亚工商会总主席阿尔沙德·拉吉德、老挝国家工商会主席苏万那冯、马来西亚全国总商会总会长拿督卢成全、缅甸工商会联合会主席佐敏温、菲律宾工商总会会长杨辉戈、新加坡工商联合总会主席林明彦、泰国工业联合会主席郑树邦、越南工商会秘书长兼越南可持续发展工商理事会副主席阮光荣发表视频致辞，中国国际贸易促进委员会副会长张少刚出席并致闭幕辞。中国国际贸易促进委员会副会长张少刚、马来西亚大马银行董事长哈希姆（线上）、泰中企业合作委员会主席刘汉炎（线上）、大韩贸易投资振兴公社中国地区总部总代表洪彰杓、日本贸易振兴机构广州事务所长清水显司围绕“RCEP引领未来增长”进行特别对话。中国集装箱行业协会常务副会长兼秘书长李牧原，新加坡太平船务集团执行主席、广西新中产业投资有限公司董事长张松声（线上），广西壮族自治区发展和改革委员会副主任黄文川，中远海运集装箱运输有限公司副总经理、党委委员隋军，中铁集装箱运输有限责任公司党委委员、中铁联合国际集装箱有限公司董事、总经理王德占，广西运多多供应链管理有限责任公司总经理王正波围绕“共建国际陆海新通道，培育开放合作新机遇”进行专题研讨。中国国际金融股份有限公司董事总经理、东南亚投资银行主管林曦，中国银行（香港）有限公司环球企业金融部总经理卢莹（线上），渣打银行（中国）有限公司“一带一路”业务全球主管明蕾（线上），交通银行广西分行副行长黄韶宇围绕“推动金融开放与创新，发掘互利共赢新动能”进行专题研讨。论坛发布了《中国—东盟国家工商界关于加强共商共建共享陆海新通道合作倡议》，举办了推动陆海新通道跨境供应链数字化协作启动仪式。

5. 成功举办中国—东盟商事法律合作研讨会。本届研讨会以“RCEP背景下的法律服务新机遇”为主题，围绕RCEP签署后商事法律领域国际热点进行全方位探讨，促成中国贸促会和老挝国家工商会签署《成立中国—老挝商事法律合作委员会备忘录》、广西自治区高级人民法院和广西贸促会签订《建立涉外商事纠纷诉讼与调解对接机制合作备忘录》，并举行广西国际商会驻新加坡、马来西亚商事法律服务点揭牌仪式，发布《RCEP背景下中国—东盟商事仲裁协同机制研究白皮书》，提升RCEP背景下的中国—东盟商事法律领域合作水平，为区域内经贸合作高质量发展保驾护航。

Achievements of the 18th CABIS

1. Chinese President Xi Jinping sent a congratulatory letter to the 18th China-ASEAN Expo (CAEXPO) and China-ASEAN Business and Investment Summit (CABIS), noting that China is willing to strengthen strategic mutual trust with ASEAN, deepen cooperation in fighting the pandemic, economy, trade and other areas, and promote the early coming into force and implementation of the Regional Comprehensive Economic Partnership (RCEP) as well as high-quality joint construction of Belt and Road, so as to forge a higher-level strategic partnership and jointly maintain the good momentum of regional prosperity and development. Chinese Vice President Wang Qishan delivered a speech at the Opening Ceremony of the 18th CAEXPO and CABIS, putting forward a five-pronged proposal as follows: first, align the Belt and Road Initiative with ASEAN countries' development strategies to jointly foster strategic partnership of higher level; second, expand economic and trade cooperation and improve the well-being of the people; third, deepen anti-pandemic cooperation and strengthen public health capacity building; fourth, nurture new driving forces for development to promote economic recovery in the region; fifth, strengthen people-to-people and cultural exchanges and cooperation with the ASEAN to deepen mutual understanding and friendship between peoples.
2. H.E. Phankham Viphavanh, Prime Minister of Lao People's Democratic Republic, His Majesty Sultan Haji Hassanal Bolkiah, Sultan and Yang Di-Pertuan of Brunei Darussalam, H.E. Samdech Techo Hun Sen, Prime Minister of the Kingdom of Cambodia, the Honorable Dato' Sri Ismail Sabri bin Yaakob, Prime Minister of Malaysia, H.E. General Prayut Chan-o-cha, Prime Minister of the Kingdom of Thailand, H.E. Arif Alvi, President of the Islamic Republic of Pakistan, H.E. Heng Swee Keat, Singapore Deputy Prime Minister and Coordinating Minister for Economic Policies, H.E. Le Van Thanh, Deputy Prime Minister of Vietnam, H.E. Dr. Pwint San, Union Minister for Commerce of the Republic of the Union of Myanmar, H.E. Lim Jock Hoi, Secretary-General of ASEAN gave speeches via video as part of the Opening Ceremony. H.E. Lu Xinshe, Secretary of the CPC Guangxi Committee and Chairman of the Standing Committee of Guangxi People's Congress, H.E. Yu Jianhua, Vice Minister of Commerce and Deputy International Trade Representative of China. Gao Yan, Chairperson of the Organizing Committee of CABIS and CCPIT also made their remarks at the Opening Ceremony. H.E Governor of Guangxi Zhuang Autonomous Region chaired the Opening Ceremony.

3. Round-table Dialogue between H.E. Sonexay SIPHANDONE, Deputy Prime Minister and Minister of Planning and Investment of Lao PDR and CEOs from China was successfully held. Topic: Sharing New Opportunities in Development, Seeking New Achievement in Cooperation. H.E. Sonexay SIPHANDONE had a dialogue with 5 CEOs from China: Mr. Meng Zhenping, Board Chairman of China Southern Power Grid Co., Ltd., Mr. Shi Jialin, Chairman and CEO of China-ASEAN Information Harbor Co., Ltd., Mr. Ma Zeping, Deputy General Manager of China State Construction Engineering Corporation, Mr. Gao Feng, General Manager and Deputy Party Secretary of the Party Committee of CHINA RAILWAY International Co., Ltd., who have played an important role in promoting the bilateral economic and trade cooperation between China and Laos. Project totaling over USD 9.295 billion cooperation by Chinese and Lao enterprises in infrastructure, electricity, digital economy were promoted. The dialogue was chaired by H.E. H.E. Gao Yan, Chairperson of CCPIT and the Organizing Committee of CABIS and H.E. Sun Dawei, Chairman of Chinese People's Political Consultative Conference Guangxi Committee gave remarks. H.E. Jurin Laksanawisit, Deputy Prime Minister and Minister of Commerce of Thailand, Mohammad Hanafi Abdul Rahman, President of NCCIBD, Mr. Neak Oknha Kith Meng, President of CCC, M. Arsjad Rasjid P.M., Chairman of KADIN Indonesia, Mr. Oudet SOUVANNAVONG, President of LNCCI, Dato Low Kian Chuan, President of NCCIM, Mr. Zaw Min Win, President of UMFCCI, Amb. Benedicto V. In the symposium, *Memorandum of Establishment of Laos-China Commercial Law Cooperation Committee* between CCPIT and LNCCI and *Memorandum of Establishment of Foreign Commercial Dispute Litigation and Mediation Docking Mechanism* between Guangxi High People’s Court and CCPIT Guangxi Committee were signed. Guangxi Chamber of International Commerce Commercial Legal Service Office in Singapore and Malaysia were launched. *White Paper on Research of China-ASEAN Commercial Arbitration and Coordination Mechanism under the RCEP* was released. All this aims to improve the level of China-ASEAN cooperation in commercial law under the RCEP and guarantee the high-quality development of regional economic and trade cooperation.
