来由

2003年10月，中国国务院总理温家宝在印度尼西亚巴厘岛举行的第七次中国—东盟（10+1）领导人会议上提出，每年在中国举办中国—东盟商务与投资峰会，作为推动中国—东盟自由贸易区建设的一项实际行动。这一建议得到东盟各国领导人的积极响应，并写入会议的主席声明。

2004年11月，第一届中国—东盟商务与投资峰会在南宁成功举行。

Initiation

In October, 2003, at the 7th China-ASEAN (10+1) Summit held in Bali, Indonesia, ASEAN leaders responded positively to the proposal made by H.E. Wen Jiabao, Premier of China, which called for the annual convening of China-ASEAN Business and Investment Summit in China, as part of the actual efforts working towards the realization of the China-ASEAN Free Trade Area (CAFTA). This consensus was then voiced in the Chairman's Statement of the summit.

In November, 2004, the 1st CABIS was duly held in Nanning with full success.

第19届中国—东盟商务与投资峰会主要成果

1. 中央政治局常委、国务院副总理韩正出席第19届中国—东盟商务与投资峰会开幕大会并发表主旨演讲。他指出，2022年是中国—东盟全面战略伙伴关系开局之年，希望双方用好《区域全面经济伙伴关系协定》（RCEP）实施新机遇，不断扩大开放合作“朋友圈”，构建更为紧密的中国—东盟命运共同体。

韩正副总理提出5点倡议：一是进一步加强战略对接，全面落实《中国—东盟建立对话关系30周年纪念峰会联合声明》，建设好中国—东盟全面战略伙伴关系，探讨共同落实好全球发展倡议和全球安全倡议；二是大力提升经贸合作水平，高质量实施RCEP，共同打造中国—东盟自由贸易区3.0版，增加东盟国家优质产品特别是农产品进口，促进产业链、供应链、价值链深度融合；三是扎实推进基础设施互联互通，高水平推动共建国际陆海贸易新通道，共同建设中国—东盟信息港，促进粤港澳大湾区和海南自由贸易港建设同中国东盟合作有机结合；四是着力拓展绿色发展合作，加强生态环境保护、应对气候变化、生物多样性保护等领域合作，推动产业结构绿色升级，合作开发清洁能源，加强海洋生态系统保护和海洋资源可持续利用；五是持续促进民心相通，加强新冠疫苗研发生产等公共卫生合作，大力推进文化、教育、青年、地方、媒体等领域交流合作，不断夯实双方人文相亲的民意基础。

马来西亚总理伊斯迈尔、柬埔寨首相洪森、菲律宾总统马科斯、老挝副总理宋赛、新加坡副总理兼经济政策统筹部长王瑞杰、泰国副总理兼外长敦·帕马威奈、越南常务副总理范平明和东盟秘书长林玉辉等通过视频方式发表致辞。中国广西壮族自治区党委书记、人大常委会主任刘宁，中国商务部副部长、国际贸易谈判代表王受文，中国—东盟商务与投资峰会组委会主任、中国国际贸易促进委员会会长任鸿斌在开幕大会上分别发言。中国广西壮族自治区主席主持开幕大会。

2. 成功举办马来西亚政府与中国企业CEO圆桌对话会。主题：深化中马经贸合作，实现共赢发展。马来西亚交通部部长魏家祥、国际贸易与工业部副部长林万锋与在中马经贸合作中发挥重要作用的6位中国企业CEO：中国交通建设集团有限公司总经理王海怀、中国能源建设集团（股份）有限公司副总经理吴云、广西北部湾国际港务集团有限公司董事长李延强、中国—东盟信息港股份有限公司董事长鲁东亮、太平洋建设集团董事局主席严昊、福建吴钢集团董事长陈法官分别开展对话。双方在能源、基础设施、产业园区、电子信息等领域达成共识，推进逾170亿美元的合作项目建设。马来西亚驻华大使努西尔万主持对话会。中国国际贸易促进委员会副会长张少刚、中国广西壮族自治区主席致辞。

4. 成功举办中国—东盟商事法律合作研讨会。主题：新发展·新格局：深化RCEP知识产权保护与国际合作。广西壮族自治区党委书记、自治区人大常委会主任刘宁，最高人民法院副院长、第一巡回法庭庭长杨万明，中国贸促会副会长张少刚，国家知识产权局副局长胡文辉等出席并致辞。研讨会取得了一批商事法律重大成果：推动设立中国—东盟自由贸易区南宁国际商事法庭，成立广西商事调解协会，在RCEP成员国全覆盖建立中国国际商会广西商会商事法律服务点，发布中国贸促会“贸法通”平台英语、老挝语和缅甸语咨询热线，签署RCEP框架下广西知识产权国际交流合作平台建设战略协议。通过这些交流平台，推动国际通行的诉讼、仲裁、调解、协商等四大商事纠纷主要解决途径全部落地广西，形成了“四位一体”的国际商事争端多元化解决机制，揭开广西商事法律服务高质量护航市场化法治化国际化营商环境建设的新篇章。

Achievements of the 19th CABIS

1. H.E. Han Zheng, member of the Standing Committee of the Political Bureau of the CPC Central Committee and Vice Premier of the State Council of China, attends the opening ceremony of the 19th CABIS, and delivers a keynote speech. He highlights that 2022 is the first year of the China-ASEAN comprehensive strategic partnership. The Vice Premier expresses hope that both sides will make good use of the new opportunities in the implementation of the Regional Comprehensive Economic Partnership (RCEP) and continue to expand fields of cooperation, thereby building a closer China-ASEAN community with a shared future.

Vice Premier Han Zheng puts forward 5 proposals: First, to further enhance strategic alignment, comprehensively implement the Joint Statement of the ASEAN-China Special Summit to Commemorate the 30th Anniversary of ASEAN-China Dialogue Relations, build the comprehensive strategic partnership well and discuss the joint implementation of the Global Development Initiative and the Global Security Initiative. Second, to promote economic and trade cooperation, ensure the high-quality implementation of the RCEP and work toward an improved version of the China-ASEAN free-trade zone. China will increase the import of high-quality products, particularly agricultural products from the ASEAN countries. Both sides are called on to facilitate a deeper integration of the industrial, supply and value chains. Third, to promote the interconnectivity of infrastructure and the joint construction of a new international land-sea corridor, make joint efforts to build China-ASEAN Information Harbor and closely integrate the development of Guangdong-Hong Kong- Macao Greater Bay Area, Hainan Free Trade Port with China-ASEAN cooperation. Fourth, to expand green development cooperation, enhance cooperation in areas including environmental protection, climate change response and biodiversity, promote the green upgrading of industrial structures, jointly develop clean energy, and strengthen marine ecosystem protection and the sustainable utilization of marine resources. Fifth, to boost people-to-people exchanges, enhance the research, development and production of COVID-19 vaccines, vigorously promote culture, education, youth, local-level and media exchanges and cooperation, and consolidate the foundation of public opinion for people-to-people exchanges.

H.E. Dato' Sri Ismail Sabri bin Yaakob, Prime Minister of Malaysia, H.E. Hun Sen, Prime Minister of Cambodia, H.E. Ferdinand Romualdez Marcos Jr., President of the Philippines, H.E. Sonexay Siphandone, Deputy Prime Minister of Lao PDR, H.E. Heng Swee Keat, Deputy Prime Minister and Coordinating Minister for Economic Policies of Singapore, H.E. Don Pamawinai, Deputy Prime Minister and Minister of Foreign Affairs of Thailand, H.E. Pham Leaders Binh Minh, Deputy Prime Minister of Vietnam, and H.E. Dato Lim Jock Hoi, ASEAN Secretary-General delivered speeches via video link. Chinese speakers at the opening ceremony include: H.E. Liu Ning, Secretary of CPC Guangxi Committee and Director of the Standing Committee of the People's Congress of Guangxi, H.E. Wang Shouwen, Vice Minister of Ministry of Commerce of China (MOFCOM) and China International Trade Negotiation Representative, and H.E. The opening ceremony is chaired by Governor of Guangxi Zhuang Autonomous Region.

Minister of Transport of Malaysia, Datuk Seri Ir. Dr. Wee Ka Siong, and Deputy Minister of International Trade and Industry of Malaysia, Datuk Lim Ban Hong, have interactive dialogues with six Chinese CEOs who play an important role in China-Malaysia economic and trade cooperation: Mr. Wang Haihuai, General Manager of China Communications Construction Group, Mr. Wu Yun, Deputy General Manager of China Energy Construction Group Co., Ltd., Mr. Li Yanqiang, Chairman of Guangxi Beibu Gulf International Port Group Co., Ltd., Mr. Lu Dongliang, Chairman & CEO of China-ASEAN Information Harbor Co., Ltd., Mr. Yan Hao, Chairman of the Board of Directors of Pacific Construction Group, and Mr. Chen Faguan, Chairman of Fujian Wugang Group Co., Ltd. Projects totaling over USD 17 billion cooperated by Chinese and Malaysian enterprises in energy, infrastructure, industrial parks, electronic information, and other fields are promoted. The Malaysian Ambassador to China, Raja Dato' Nushirwan Zainal Abidin chairs the event. H.E. Zhang Shaogang, Vice Chairman of China Council for the Promotion of International Trade, and Governor of Guangxi Zhuang Autonomous Region, delivers speeches at the dialogue.



Mr. Liu Ning, Secretary of the CPC Guangxi Committee and Chairman of the Standing Committee of Guangxi People's Congress, Mr. Yang Wanming, Vice President and First Circuit Court President of the Supreme People's Court, Mr. Zhang Shaogang, Vice Chairman of CCPIT, and Mr. Hu Wenhui, Deputy Commissioner of China National Intellectual Property Administration attend the symposium and deliver remarks. The Symposium has achieved fruitful results in commercial legal cooperation: It promotes the establishment of the China-ASEAN FTA Nanning International Commercial Tribunal and sets up the Guangxi Commercial Mediation Association; The Guangxi Chamber of International Commerce Commercial Legal Service Office in RCEP Member States is established; The CCPIT Cross-border Trade and Investment Law Service Platform (English, Lao, and Myanmar Language) Hotline is launched; The Strategic Agreement on Developing Guangxi Intellectual Property International Exchange and Cooperation Platform under the RCEP is signed. With these key exchange platforms, all the four major methods of commercial dispute resolution, namely litigation, arbitration, mediation, and negotiation become available in Guangxi, creating an Four-sphere integrated and diversified settlement mechanism of international commercial disputes, opening a new chapter of developing a market-oriented, law-based and internationalized business environment with high-quality commercial legal services in Guangxi.


